



Overview

The Pain Centre (PC) is accepting funding applications for clinical research projects focused on the study of **sex** and gender disparities in children experiencing pain. This call is in alignment with the IASP 2024 Global Theme.

Examples of possible projects include:

- Clinical studies aimed at improving the assessment, treatment, and management of pain.
- Education for patients, families, and/or policy-makers.
- Knowledge translation, quality improvement, or implementation science projects.

The PC will fund **one (1) seed grant** with a maximum budget of \$10,000 CDN. It is anticipated that this seed funding will enable the investigative teams to subsequently develop larger research projects that will attract external funding and lead to changes in practice. The **award duration will be 12 months**. A progress report will be required at 1 year at which time a request for an extension of up to 12 months will be considered. Unused funds at the end of 2 years will be returned to the granting Centres.

Applications should be written for a broad audience (e.g., clinicians, researchers, patient partners) and not specifically for experts in the field. **Jargon should be kept to a minimum in the lay summary**.

Eligibility

- Each application may have a single PI, or Co-PI's as the "Principal Applicant"
- Principal Applicant must be a SickKids staff member (including researchers, clinical staff, fellows, research associates, nurse, and allied health professional and directors/managers/coordinators).
- If the Principal Applicant does not hold a research appointment with the Research Institute (RI), a co-applicant with a research appointment must agree to act as the Principal Investigator on all official communications with the RI (transfer of award, Research Ethics Board approvals, management of cost centre, etc).
- There may be unlimited co-applicants per application. Co-applicants are not required to be from SickKids.
- Principal Applicants may be listed as co-applicants in other submissions.
- Applicants for this grant will not be eligible to be part of the Grant Review Committee.



2024 Seed Grant Guidelines

Application Process and Adjudication

Deadline: Monday October 21, 2024 at 5:00pm

Submit to: pain.centre@sickkids.ca

Grant applications must be completed and submitted as per the instructions. Late submissions will not be considered. Written applications will be reviewed by a merit Grant Review Committee. The top scoring project will be awarded funding.

Review Criteria

Innovation	Proposed work represents novel, unique concepts and creative thinking.
Potential for future development and dissemination	High likelihood that proposed work will enable future expansion. Is this important proof-of-concept work that will lead to new research directions or larger funding applications or development of new research teams? For clinical projects, is this a program that might be applied in other settings and other Centres and achieve wider dissemination? For education projects, is this a program that could be disseminated or expanded?
Measures of impact	This is perhaps the most important criterion. How will the work impact its intended target or field of inquiry? Measures must be clearly delineated and specific to the proposed work.
Significance	Does this project address an important problem or critical barrier related to paediatric cardiac pain?
Quality of the proposal	Are the overall strategies, methodologies and analyses well-reasoned and appropriate to accomplish the objectives of the project? Are potential problems, alternative strategies, and benchmarks for success represented? Is the strategy feasible and does it mitigate risk?
Strength of Team	Does the project team have the expertise and experience required to successfully complete this project in a timely manner?
Budget	Is the budget sufficient to perform the work proposed successfully? Is the budget reasonable and well justified? Has this project received funding from other sources? If so, please explain.
